He led us through a delightful series of PowerPoint slides illustrating Robbie and his visit to 5 of the chateaux that are part of the UNESCO World Heritage site in the Loire valley in France. The 5 chateaux were the Royal Chateau of Blois, Chateau D'Amboise, Chateau Chenonceaux, Parc & Chateau Beauregard and Chateau Cheverny.
- At Blois he highlighted the significance of porcupine and salamander emblems, a useful and intriguing iPad, and closets with secret mechanisms for opening them.
- The gardens of Amboise were next with amazing views of the Loire and another iPad provided with the entry fee.





- Chenonceaux was a fortified bridge over the river Cher with two very large formal gardens. It featured the Medici gallery and the largest apothecary in France.
- Beauregard was in 40 acres of park. It had a set of 10 walled off gardens each featuring a
 different color of flowers and bushes, a room of painted dog portraits and a 6-meter-long
 parchment agreement showing who owned the chateau.





Cheverny was the Brooks' favourite. It has been owned by the same family for over 600 years.
Famous for connection to Tin Tin. The present owners still live there and it is an important
hunting venue with about 100 hounds. John M gave a vote of thanks which was acknowledged
with acclamation. Another interesting session that took us away from Melbourne's cold.
President Bill closed the meeting after unwrapping the raffle winners Warwick S and Bill M.
The raffle raised \$40.

WomenCAN

WomenCAN Australia is a charity dedicated to assisting women become work ready, through education. Our program, The Placement Circle (TPC), supports vulnerable or isolated women to build their confidence to re-skill and re-connect with the work force so that they can gain financial independence. The TPC program is a tripartite model connecting communities of peer supported women to their local TAFE and place-based employers, matching training to sectors with high labour demand such as Aged Care, Trades, Cybersecurity, and Transport.

We recognise that women who become disconnected from the workforce are at real risk of poverty, homelessness, and despair, as are their dependents. By working together in a structured peer supported community of women with a shared lived experience, the possibility of re-educating, finding sustainable employment and rebuilding confidence becomes more likely.

WomenCAN Facilities Services (WCFMS) is our social enterprise, providing a unique woman to woman facilities maintenance business. Our qualified tradeswomen provide trades, gardening, cleaning, and other residential services to women in their homes.

Our primary market is crisis accommodation housing where we assist vulnerable and often traumatised women who live in rooming houses, or short & long-term accommodation.

The mission of WomenCAN Facilities Services is to provide an excellent and safe home maintenance service for women by women.

The social enterprise has significant social impact due to the connection with our charity's program, TPC -

- o Those women who are training in trades have career opportunities with us on graduation,
- Those whose English prevents them from enrolling currently in TAFE can work with us as cleaners and gardeners and
- The profits generated by the social enterprise help to finance the charity.

COUNCIL RESOLUTION

Moved by Cr Massoud, Seconded by Cr Munroe

That Council:

- 1. Publicly declares a Climate Emergency, recognising the Whitehorse community's sustained strong support for Council to lead and act on climate change, including as expressed in the 2040 Community Vision;
- 2. Notes that all actions that flow from this Declaration are included in the existing Whitehorse Interim Climate Response Plan 2020-2022 and any subsequent Climate Response/Action Plan adopted by Council;
- Acknowledges that funding for actions arising as a consequence of this Climate Emergency declaration will be limited to and align with Council decisions taken as to Budget allocations for the implementation of any adopted Climate Response/Action Plan; and
- 4. Provides clear communication on its website that Whitehorse City Council has declared a Climate Emergency.

The second item concerns the implementation of a

Waste Service Charge.

After much deliberation and community consultation the Council decision is as follows.

Conclusion

It is recommended that Council implement a Waste Service Charge commencing in the 2023/24 financial year. The Waste Service Charge provides a fair and transparent way to charge the cost of waste that is consistent with reducing waste and increasing recycling.

The recommended Waste Service Charge model includes applying a service rate to the components of the Charge including:

- •Kerbside Waste Service Charge (80 litre red lid garbage bin and 240 litre yellow lid recycling bin);
- •Public Waste Service Charge; and
- •Supplementary Bin Charge (any bins in addition to the standard service of an 80 litre red lid garbage bin and 240 litre yellow lid recycling bin).

The amount of the Waste Service Charge including the charges for supplementary bins will be developed as part of budget considerations for 2023/24.

The next steps following a decision of Council is to commence preparing the budget for 2023/24 and to update relevant Policies, Plans and other documents to include details of a Waste Service Charge.

Powerhouse Cheese Barbara Power started making her own cheeses over 10 years ago. With a degree in Microbiology, she had a good scientific foundation to base her production. Two years ago, she started up her own commercial business **Powerhouse Cheese** and persuaded her sister, Donna Hall, who also has a Science degree, to leave her native New Zealand and join her in this venture. These two Artisan Cheesemakers use cow's milk in small 100 litre batches of milk from St David's Dairy in Fitzroy. They sell their cheeses at markets every Saturday and Sunday around the Melbourne area or you can order online for pick up on Monday afternoon. The rest of the week you will find them busy in their cheesery making their standard Blackburn Blue, Whitehorse White and Ash Bree cheeses or producing new varieties like their Bellbird Blue or a surface ripened Rosella Red which may become another standard offering in the future. Certainly, these two talented very local artisan cheesemakers running **Powerhouse Cheese** have a future.
